PROBUS Schedule of Pro Rata Fees Due

SUBSCRIPTIONS:

Members of the club shall pay a joining fee (if any) and an annual subscription.

The annual subscription is set at the club AGM in March and is due and payable on April 1st each year. Should a member have not paid the annual subscription by June 30th the committee may recommend to members the termination of that member's membership.

The subscription of a person joining the club is to be paid pro-rata plus the joining fee on a quarterly basis. That is, where a person joins the Club during the:

±Quarter ending June 30 th	Subscription & joining fee to be paid in full	\$85.00
±Quarter ending September 30 th	Three-quarters of subscription plus joining fee is payable.	\$70.00
±Quarter ending December 31 st	One-half of subscription plus joining fee is payable	\$55.00
±Quarter ending March 31 st	One-quarter of subscription plus joining fee is payable	\$40.00

Notwithstanding the date upon which a person joins the Club, the joining fee (if any) is payable in full. The joining fee is required to produce a club name badge, pay the PSPL registration fee, certificate of membership, emergency information card and other items in the new members 'kit'.
